

Agreement on use of Town of Upper Marlboro Flatbed Truck

As a service for our residents only, the Town of Upper Marlboro will allow residents to reserve the Town's Public Works flatbed truck over the weekends (weather permitting) for the loading of acceptable and approved waste materials into the truck-bed for disposal on the following Monday. Requests will be taken on a first-come, first-served basis and by requesting the truck (and your use of it) you agree to the following:

1. The availability of the truck is subject to use (or anticipated use) of the truck by the Town.
2. You agree **not** to load the truck with any of the following:
 - Construction and demolition debris
 - Stumps and logs
 - Skids and pallets
 - Drums, tanks, kegs, and barrels (plastic or metal) greater than 55 gallons in size.
 - Drums, tanks, kegs and barrels (plastic or metal) less than 55 gallons in size if they are not flattened. (The items must be empty and flattened to load)
 - Hazardous and biohazard/medical wastes
 - Compressed cylinders of any size, shape type or condition
 - Asbestos
 - Liquids, to include sewage and septic waste
 - Radioactive material
 - Animal carcasses
 - Automobiles or related parts
 - Chemical and/or petroleum cleanup waste
 - Plastic packing material and spoil
 - Soil, rock, grubbing material and spoil
 - Ash
 - Shingles and roofing materials
 - Tires
 - Bulky trash such as, refrigerators, washing machines, dryers, hot water heaters, and lawn mowers (Call Town Hall to arrange pick up of acceptable bulky trash).
3. The truck is available only for material(s) generated by the resident(s) at your home only. If you have a contractor working at your home you may not reserve the Town's truck.
4. You agree to indemnify and hold the Town harmless for: (a) any damage to your property, or surrounding properties. (b) any injuries to you and/or others on your property. (c) any damage to the truck while parked or operated on your property. (d) damages due to improper or unauthorized loading or use of the truck. (e) any other damages or injury to persons or property sustained while you are operating or are in possession of the truck that exceeds Town insurance policy coverage or statutory tort claim limits.
5. You agree to pay for any costs to the Town resulting from a violation of this agreement plus a \$50.00 service fee.

Each residence may only use the truck three times each calendar year.
