

PRESIDENT'S ANNUAL REPORT

The Town's Charter requires an annual report by the President on "...the condition of municipal affairs and make such recommendations he deems proper for the public good and welfare of the Town."

OVERVIEW: This past year, we increased Town staffing with the addition of a part-time employee in the Public Works Department. This aided us immeasurably during January's snow events, in keeping up with the demands of cleaning up after the storm. Also, a new administrative position was created at Town Hall for a Deputy Clerk. Our Town Clerk/Administrator now has the help needed to organize and archive the Town's records and keep them up-to-date.



Efforts to codify our current Town Ordinances, and to enforce current codes already on record, will continue. Using input from our citizens, via our Town website and social media, we will prioritize our areas of interest that you indicate are the most important. We are counting and cataloguing your responses to our surveys, and will do our best to meet the requests and needs of our citizens.

TOWN OPERATIONS: We intend to tap into the talent and interest of Town employees and residents to enhance the safety and well-being of the Town. We have some excellent experienced employees, who besides their professional skills, have fresh insights into communal activities and offer us a good starting point.

A recent example of this engagement has been our 3 potential Town flag design and slogan entries that make a statement about the uniqueness of the Town of Upper Marlboro.

The Town has repopulated its Sustainable Community Workgroup (SCW), and will deliver updates on this multipronged program at each monthly Town Meeting. Christina Pompa from MNCPPC along with SCW Chair, Steve Sonnett, have been instrumental in carrying the torch further in the Town's efforts to grow and attract more business opportunities for our Town.

We've been blessed with a strong financial legacy from our previous administration's best practice of being "Lean & Clean"; a financially responsible municipality (one of only a few in the County). The fact that we are unburdened with debt will allow us to diligently work to improve our infrastructure with judicious capital expenditures for the Elm & Pratt Street improvements. Besides the Town Hall Addition Project and the Public Work's Facility Upgrade, we will continue efforts to better serve our citizen's needs.

The Town's membership in the County's I-Net community is coming close to fruition. Currently, there are 23 municipalities that are members. Once we are

connected to the system, we will have the additional information available on the County-run government intranet. This will be beneficial in linking our town with other municipalities, keeping us informed and in step with the best practices within the County. Cable is currently being laid along Route 4 (now in phase 3 of 4 phases) and we are being reassured that this service will be available to us later this year.

RECOMMENDATIONS:

We have enhanced our Social Media outreach to better collect input from our residents. By utilizing Facebook & Twitter, we will be better able to “Look, Learn, & Grow” as a community. In addition to formulating a Community Emergency Response Team (CERT), we will be formulating other emergency operations plans, that are tailored to our Town, and cover an array of possible emergency situations. Once

again, we will be utilizing the skills of Town employees who have had previous experience in providing these services for other municipalities in the County.

Besides completing our current proposed Capital Improvement Projects, our long-term strategy is to reinvigorate the Town through communal activities. There is continued interest in the possible use of the empty lot across from the Town Hall on Old Crain Hwy. We are currently exploring ideas for some type of Community Park, or volunteer agrarian Town activity. We hope to “prime the pump” for community engagement and volunteerism. Please feel free to contact us with your ideas and insights. With your support, we will continue to offer our citizens the lowest tax rate in the County, combined with the public-oriented support that resi-

ON THE AGENDA

At the March 2016 Town Meeting, the Board of Town Commissioners will introduce for passage a Charter Amendment Resolution that authorizes an alternate to record the minutes at meetings of the Board of Town Commissioners should the Clerk not be able to attend. As it is, the Board cannot hold a meeting without the Town Clerk being present to take the minutes for the record. This additional language amending Section 82-57 (Clerk to the Board) of the Town Charter will greatly assist our ability to maintain the Board's monthly meeting schedule as planned. In addition, this amendment will provide valuable training for the new Deputy Clerk position that was created last fall. The meeting is at Town Hall and starts at 7:30 p.m.
